Thank you for your interest in our Voluntary Pre-Kindergarten Program (VPK)!

- All registrations are on a first come, first served basis.
- **February 22nd Sibling Preference Enrollment** We will be registering VPK students who currently have a sibling in the City of Cape Coral Charter School System (Christa McAuliffe Elementary, Oasis Elementary, Middle or High School). You may come anytime between **7:30 and 4:00 pm**.
- March 6th Open Enrollment We will be registering families that do <u>not</u> currently have a child in the City of Cape Coral Charter School System. Enrollment begins at 7:30 am. Waiting numbers will be distributed to parents beginning at 6 am.

STEP 1 – ENROLLMENT THROUGH THE EARLY LEARNING COALITION:

In order to participate in a state VPK program, you must register with the Early Learning Coalition (ELC) and receive a registration confirmation. The following options are available for registering your child.

<u>STEP 2 – ENROLLMENT AT CHRISTA McAULIFFE:</u> The following documents must be brought with you in order to register your child for the VPK program at Christa McAuliffe Elementary.

- 1. **VPK Enrollment Voucher** from the ELC (refer to step 1 above)
- 2. A completed **student registration form** (included with this packet)
- 3. Original birth certificate
- 4. **Proof of residency** (water bill, electric bill or a signed lease agreement)
- 5. A current **immunization record** (form 680) and **physical form** (within 12 months) are REOUIRED. These can be obtained from your pediatrician.

Once your application is approved, you will receive a **VPK voucher** via email that you must

- 6. If available, your student's social security card
- 7. **Proof of custody** must be provided if the student does not live with both natural parents.
- 8. **Student's IEP** must be provided if the student is receiving ESE services (speech, language, early intervention).
